1. Executive Summary

6. Background/Introduction/Discussion

In terms of section 25(1) of the Systems Act a municipal council must within a prescribed period after the start of its elected term, adopt a single, inclusive and strategic plan for the development of the municipality. The process to compile the 2017/2021 IDP for the next 5 year cycle started in August 2016 with inputs from councillors, ward committees and officials.

The draft IDP for 2017/2021 which was tabled in Council on 29 March 2017 was advertised for public scrutiny and comment in the local newspapers until 2 May 2017. Attached is a copy of the advert which appeared in the Hermanus Times, Overstrand Herald and Gansbaai Courant on 30 March 2017. (Annexure A).

The document was also placed on the municipal website and was available at the municipal libraries from 30 March 2017 until 2 May 2017. The draft IDP was also presented during the IDP/Budget road show held from 3- 26 April 2017.

No IDP specific comments were received during the public comment period from 30 March 2017 until 2 May 2017. The Municipality did however after the public comment period on 5 May 2017 receive comments from Mr Anton B Meyer, Fisherhaven Developers Pty Ltd via the Overberg District Municipality (ODM) IDP office. In his comments Mr Meyer refers simultaneously to the draft IDP of both the ODM and Overstrand Municipality. Mr Meyer's comment "that ward 8- Hawston and Fisherhaven do not feature in the Overstrand's draft IDP" is incorrect. He omitted to consider the capital budget allocations to ward 8 cited in Chapter 14 (Annexure B) of Overstrand's draft IDP.

The Western Cape Provincial Government annually assesses the draft IDP's and Budgets of municipalities and feedback is given at the LGMTEC engagement. Overstrand Municipality received a positive assessment by the Western Cape Provincial Government on our draft IDP and 2017/2019 Budget during our engagement on 25 April 2017. The said assessment notes the alignment of the budget with the IDP priorities as well as the full compliance of the draft IDP with section 26 of the Municipal Systems Act.

7. Financial Implications

Provision was made on the operating budget to cover the costs associated with compilation of the document. The document was compiled in-house by our own staff.
