Ooreenkomsdig die bevoegdhede my verleen met betrekking tot die aangeleenthede genoem in artikel 79 van die Ordonnantie op Natuurbewaring, 1974 (Ordonnantie 19 van 1974), wysig ek hierby Proklamasie 357 van 28 September 1972, soos gowysig by Proklamasies 453 van 29 November 1972, 475 van 12 Desember 1972, 454 van 11 Desember 1973, 326 van 24 September 1974 en 91 van 30 Maart 1977 —

deur klousule 32 deur die volgende klousule te vervang:—

"32 (1) In ondergenoemde gebiede 16A, 16B en 16C mag niemand gebruik maak nie van —

- (a) 'n fuiknet, of
- (b) 'n aastreknet.

(2) In ondergenoemde gebied 16A mag niemand enige boot of ander vaartuig wat deur 'n motor aangedryf word, gebruik nie.

(3) In ondergenoemde gebied 16B wat vir hengeldoelendes afgesonder word, mag niemand enige boot of ander vaartuig wat deur 'n motor aangedryf word, gebruik vir die doel van snelbootjaery, glybootjaery, waterskisport of deelname aan 'n regatta, of vir enige ander doel nie uitgesender die vervoer, teen 'n snelheid van hoogstens tien kilometer per uur, van diere, goedere of persone langs die kortste roete van een punt na 'n ander punt, of om met die motor afgeskakel sodanige boot of ander vaartuig te laat dryf of voor anker te laat lê.

(4) In ondergenoemde gebied 16C mag niemand gedurende die ure vanaf 16h00 op enige dag tot en met 10h00 op die volgende dag enige boot of ander vaartuig gebruik vir die doel van snelbootjaery, glybootjaery, waterskisport of deelname aan 'n regatta, of vir enige ander doel nie uitgesender die vervoer, teen 'n snelheid van hoogstens tien kilometer per uur, van diere, goedere of persone langs die kortste roete van een punt na 'n ander punt, of om met die motor afgeskakel sodanige boot of ander vaartuig te laat dryf of voor anker te laat lê.

(5) In ondergenoemde gebied 16D is daar geen beperkings nie op die gebruik van enige boot of ander vaartuig wat deur 'n motor aangedryf word, vir die doel van snelbootjaery, glybootjaery, waterskisport of deelname aan 'n regatta of vir enige ander doel; met dien verstaande dat die Sekretaris van die Afdelingsraad van Caledon die gebruik van enige sodanige boot of ander vaartuig gedurende 'n tydperk wanneer daar seilregattas gehou word, kan verbied.

(6) In ondergenoemde gebied 16E wat vir die doel van 'n voëlsreservaat afgesonder word, mag niemand enige boot of ander vaartuig wat deur 'n motor aangedryf word, gebruik nie tensy hy diehouer is van 'n permit wat hom magtig om sodanige boot of ander vaartuig te gebruik vir geen ander doel nie as vir die vervoer, teen 'n snelheid van hoogstens tien kilometer per uur, van diere, goedere of persone langs die kortste roete van een punt na 'n ander punt, of om met die motor afgeskakel sodanige boot of ander vaartuig te laat dryf of voor anker te laat lê.

(7) In ondergenoemde gebied 16F mag niemand enige boot of ander vaartuig wat deur 'n motor aangedryf word, gebruik nie uitgesonderd persone wat oewereienaars is met betrekking tot dié gedeelte van die Kleinrivier vermeld in die omskrywing van 'Gebied 16F' en wat ingevolge die een van ander wetsvoorskrif of uit hoofde van enige toestemming of permit wat regsgeldiglik verleent is, geregtig is om enige sodanige boot of ander vaartuig sonder enige beperkings hoegenaamd te gebruik.

## CONTROL OF INLAND WATERS

In accordance with the powers vested in me in relation to the matters referred to in section 79 of the Nature Conservation Ordinance, 1974 (Ordinance 19 of 1974), I hereby amend Proclamation 357 dated 28 September 1972, as amended by Proclamations 453 dated 29 November 1972, 475 dated 12 December 1972, 454 dated 11 December 1973, 326 dated 24 September 1974 and 91 dated 30 March 1977 —

by the substitution for clause 32 of the following clause:—

"32 (1) In the undermentioned areas 16A, 16B and 16C no person shall use —

- (a) a fyke-net, or
- (b) a bait trek-net.

(2) In the undermentioned area 16A no person shall use any boat or other craft which is propelled by an engine.

(3) In the undermentioned area 16B which is set aside for angling purposes no person shall use any boat or other craft which is propelled by an engine for the purpose of speedboating, aquaplaning, water-skiing or taking part in a regatta, or for any other purpose other than the transportation, at a speed of not more than ten kilometres per hour, of animals, goods or persons by the shortest route from one point to another point or causing such boat or other craft to drift with the engine switched off or lie at anchor.

(4) In the undermentioned area 16C no person shall, during the hours from 16h00 on any day up to and including 10h00 on the following day, use any boat or other craft for the purpose of speedboating, aquaplaning, water-skiing or taking part in a regatta, or for any purpose other than the transportation, at a speed of not more than ten kilometres per hour, of animals, goods or persons by the shortest route from one point to another point or causing such boat or other craft to drift with the engine switched off or lie at anchor.

(5) In the undermentioned area 16D there are no restrictions on the use of any boat or other craft propelled by an engine for the purpose of speedboating, aquaplaning, water-skiing or taking part in a regatta, or for any other purpose; provided that the Secretary of the Divisional Council of Caledon may prohibit the use of any such boat or other craft during any time when sailing regattas are held.

(6) In the undermentioned area 16E which is set aside for the purposes of a bird sanctuary, no person shall use any boat or other craft which is propelled by an engine unless he is the holder of a permit authorizing him to use such boat or other craft for no other purpose than the transportation, at a speed of not more than ten kilometres per hour, of animals, goods or persons by the shortest route from one point to another point or causing such boat or other craft to drift with the engine switched off or lie at anchor.

(7) In the undermentioned area 16F no person shall use any boat or other craft which is propelled by an engine, with the exception of persons who are riparian owners in relation to that part of the Klein River referred to in the definition of 'area 16F' and who in terms of some or other provision of law or by virtue of any permission or permit granted legally, is entitled to use any such boat or other craft without any restrictions whatsoever.

#### Gebied 16E

#### Gebied 16F

**AREA 16 F**—Only riparian owners are entitled to use power driven boats.

**AREA 16 E**—Bird sanctuary. No power-boats, except by permit.

**AREA 16 D**—No restrictions on watersport. ~~Regatta Council~~ may prohibit power driven boats when sailing regattas are held.

**AREA 16 C**—No watersport with power driven boats during 16h00 on any day to 10h00 the following day. Only angling is then allowed. Watersport with power driven boats allowed only from 10h00 to 16h00 on the same day.

**AREA 16 B**—Angling area. No Watersport with power driven boats or crafts. Boats allowed to transport goods etc. at 10km per hour.

**AREA 16 A**—No boat or craft propelled by engine allowed.
