6. Background/Discussion/Evaluation/Conclusion**Background**

The Kleinmond Special Rating Area was established in terms of the Special Rating Area By-Law (promulgated as per Provincial Gazette Extraordinary 7692 dated 21 October 2016) for a term ending on 30 June 2025.

An application was received from the Kleinmond SRA NPC for the extension of the term of the Special Rating Area from 2025 until 2030.

Discussion/Evaluation/Conclusion

The extension of the term of an SRA is dealt with in the Municipality's Special Rating Area By-Law and Special Rating Area Policy.

Item 15 of the Special Rating Area By-Law provides for the management body of an SRA, if it so elects, to apply for the extension of the term of the SRA and such application must be made on or before 1 September in the year before the year in which the business plan is due to terminate. Whilst the application was not submitted timeously, the late submission was condoned by Council at an Ordinary Meeting of Council held on 30 October 2024.

The KSRA was established after following due process and at a Special Council Meeting held on 17 March 2020 per item 4.1. There has been no amendment to the business plan and the SRA mapped area has also remained the same. The SRA business plan, budget, and implementation strategy was presented to the Annual General Meeting of the KSRA held on 11 September 2024 and approval for the extension was obtained unanimously.

The budget of the KSRA will be funded from a special rate to be approved by Council annually as part of the budget process.

7. Financial Implications

An additional rate will be levied on properties in the KSRA in terms of section 22(1)(b) of the Local Government Municipal Property Rates Act, Act 6 of 2004.

Application for the extension of the Kleinmond Special Rating Area term

The Board of Directors of the Kleinmond Special Rating Area NPC hereby officially applies for the extension of the KSRA term for the term 1 July 2025 to 30 June 2030.

The KSRA Board has conducted a public opinion survey aimed at determining, among other things, how safe respondents feel in public spaces during the day and night, testing perceptions regarding the activities of KSRA, identifying what respondents believe KSRA should focus on, determining whether property owners believe they are getting value for their money, and assessing whether respondents are in favour of extending the KSRA term for another five years.

The internet-based platform SurveyMonkey was used to gather and process responses.

The questions in the survey were clarified beforehand with the CFO.

The platform was open for respondents from 28 May to 26 June 2024, after which the results were processed.

571 respondents participated in the survey. This represents more than 16% of the total number of individual property owners, which, in terms of generally accepted norms for the validity of surveys of this nature, is far more than sufficient.

The respondents were asked to indicate on a scale from 1 (strongly oppose) to 5 (strongly support) whether they support the extension of the KSAG term for another five-year period.

3.34% chose 1 or 2,
 5.61% chose 3, and
 91.05% chose 4 or 5.

This result gave the KSAG Board the confidence to proceed with the process of asking for a final decision on this matter at its Annual General Meeting.

2. KSRA business plan

KSRA plans to proceed with the objectives in the initial business plan as approved by the OM Council on 17 March 2020. This business plan was updated, submitted to the CFO for input and tabled at the KSRA AGM on 11 September 2024 where it was approved unanimously.

The business plan includes the implementation plan and five-year term budget for the period from 1 July 2025 to 30 June 2030.

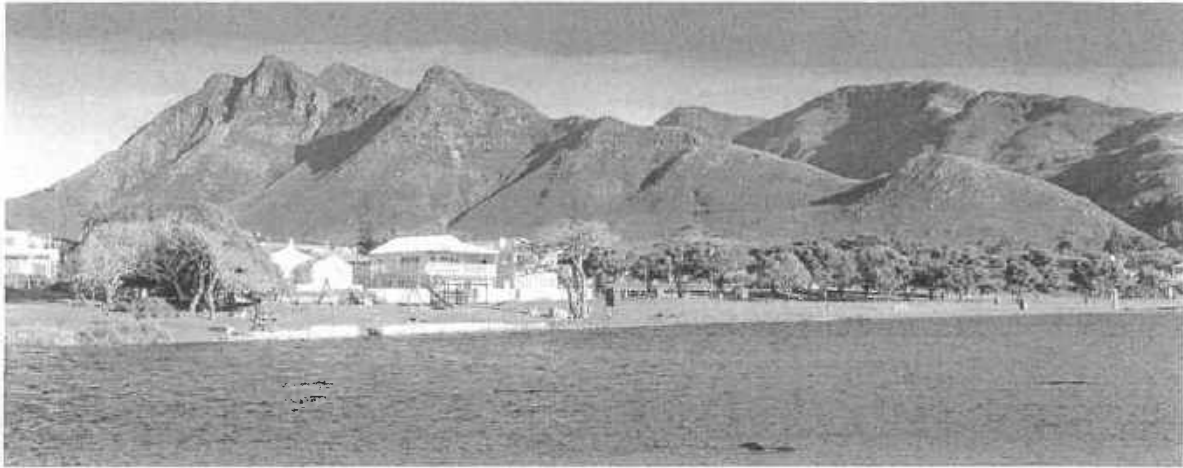
There was a quorum present at the meeting, either in person or by proxy.

1. Executive summary

This business plan describes the intention of the Board of Directors of the Kleinmond Special Rating Area NPC to apply for the extension of the term of KSRA for a further five years. The *Overstrand Municipality: Special Rating Area By-law 2016* allows property owners to supplement municipal services with top-up services considered by them to be appropriate for satisfying the peculiar needs of their community. This business plan describes these envisaged services and how they would align with the provision of law enforcement and a healthy urban environment as intended in the Overstrand's Integrated Development Plan (*Final IDP review and amendment 2024-25 - 31 May 2024*). The boundaries of the KSRA enclose all properties between the mountain and the coastline, and within the area of Kleinmond between Heuningkloof in the east and Palmiet and Overhills in the west.

A survey among property owners indicated that the vast majority of respondents are satisfied with the additional services provided by KSRA and are in favour of extending the term.

KSRA plans to proceed with the objectives in the initial business plan as approved by the OM council on 17 March 2020, and aims to continue assisting the Overstrand Municipality by:

- improving the monitoring of public areas using advanced technology;
- identifying, reporting and following up any need for restoring public spaces to prevent urban decay;
- maintaining a clean and healthy environment through inspection and by reporting and following up any threat to the environment and any aberration of acceptable levels of cleanliness and appearance of public spaces;
- maintaining a safe environment for all the residents and visitors to the town; and
- monitoring the violation of municipal by-laws and reporting inappropriate behaviour in public areas by informing law enforcement services to deal with these issues.

The cost of providing these services is expected to be in the region of R1,6 million annually at 2025/6 monetary value, sourced by the Municipality from rateable property owners' property rates as envisaged in the five-year budget and implementation plan described in this business plan.

The KSRA non-profit company was established on 28 January 2021 and registered with the Companies and Intellectual Property Commission.

It is managed by a Board of Directors elected by the members of the company at Annual General Meetings.

2. What is a special rating area?

"The special rating area model is based on international best practice. It is aimed at preventing the degeneration of towns and the consequential urban decay, and facilitating their upliftment, economic growth and sustainable development.

*"The Overstrand Municipality recognises special rating areas as a potential tool for assisting it to fulfil its constitutional and statutory obligations to allow property owners within a geographical area to improve and upgrade their area by means of a property rate in addition to the standard property rate."*¹

The Western Cape Government promulgated the *Special Rating Area By-law* (Appendix A) in 2016 and the Overstrand Municipality approved the *Overstrand Municipality: Special Rating Area Policy* (Appendix B) in 2019, revised in 2024, thereby setting the platform for property owners to establish such areas in the Overstrand Municipal area.

The Kleinmond Special Rating Area Steering Committee identified special rating area (SRA) legislation as a sustainable means of both addressing issues regarding a safe environment and preventing urban degeneration due to deterioration and neglect of the environment.

After the majority of Kleinmond property owners gave their consent to have Kleinmond declared a special rating area in 2019 and the application in terms of the by-law and policy was approved by the OM Council on 17 March 2020, the KSRA NPC with members was established on 28 January 2021. This establishment was delayed for one year because of the Covid 19 lockdown.

The company is managed by property owners from Kleinmond and is responsible for providing and managing supplementary services in addition to those already provided by the Municipality (OM). In accordance with the regulations, Kleinmond's property owners pay a monthly amount in addition to the normal property tax so that the supplementary services can be delivered.

This business plan is an update of the originally approved business plan and explains how it will be implemented in the second five-year term. The supplementary services that will be delivered on behalf of all property owners will still include the provision of systems through which issues related to a safe, healthy, and clean environment can be monitored and any problems can be reported to the authorities.

KSRA will still be funded through a special levy by the Municipality (OM) and will apply to the owners of approximately 3500 properties according to the OM's database. The additional annual levy will be calculated at a rate (currently 0.000346) in the rand on the municipal property valuation.

It is collected from the property owners in the area by the municipality and transferred to the KSRA non-profit company, which is responsible for managing the SRA. The funds are used to cover KSRA's expenses and for no other purpose. The additional levy that property owners in the SRA must pay will be proportional to the municipal valuation of their property and will be used for the benefit of the community as a whole. This additional levy and the services provided with it will not only offer individual property owners the benefit of a well-managed, safe town but also give them a sense of pride in their community and social responsibility.

3. Why should Kleinmond be an SRA?

3.1 Background and motivation

The Overstrand Municipality (OM) has an **Integrated Development Plan (IDP)** (available in pdf format as *Final IDP review and amendment 2024-25 - 31 May 2024*) at <https://www.overstrand.gov.za/integrated-development-plan-idp/final-idp-review-and-amendment-2024-25-31-may-2024-1/?layout=default> which describes the effective management of its municipal area. The IDP intends to satisfy the basic needs of the various communities and areas within the large geographical area OM serves.

The *creation and maintenance of a safe and healthy environment* is listed as one of the five strategic goals of OM.²

One of the areas of major concern in Kleinmond is the safety risks that compromise a safe environment. In the IDP these risks are identified.³

Residents of Kleinmond have first-hand experience of these problems and realize that OM's capacity to deliver a sustainable and high-quality service to all its residents is hampered by the large area it serves, shortage of resources and the fact that most of the offences do not occur within normal office hours.

3.2 Kleinmond Special Rating Area

The Kleinmond Special Rating Area (KSRA) is a geographical area which includes all residential areas of Kleinmond. It is the property owners in this area who will contribute in a sustainable manner – by means of a monthly additional rate levied on their property taxes – towards supplementary services, thereby ensuring a safer, healthy and cleaner environment for the community as a whole. This additional rate should continue to be affordable to property owners and its impact on the average property owner's rates should be as low as possible.

For more detail about estimated costs to property owners see par 8 of this business plan. The proposed supplementary services include an advanced monitoring system of CCTV cameras in identified hotspots in the town. The system will be linked to a control room which will be staffed 24/7 as well as an internet-based databank which can be utilised in cooperation with OM Protection Services when needed. In the light of existing cooperation between OM Law Enforcement and other law enforcement agencies (within the confines of their mandated functions), all the role-players will be able to access this information under strict confidentiality requirements and within the boundaries of what is legally permitted. It will be done in compliance with the *Protection of Personal Information act (POPI)* as well as the *Promotion of Access to Information act*. (See par 7 for the implementation plan.)

3.3 Boundaries of the KSRA

The boundaries of KSRA are the eastern boundary of Heuningkloof, the coastline as southern boundary, the western boundary of Palmiet and the informal settlement, and the mountain as northern boundary.

3.4 Link to the geographical area

A safe environment and the general appearance of the town concern every resident of Kleinmond. Unfortunately, contempt of municipal regulations, littering, substance abuse, alcohol abuse in public places, and other offences that have a negative impact on a safe environment

will increase, if not countered through a combined strategy among role-players in the safety of the town.

Kleinmond has two road entrances, one on each side of the town. To the north the town is bordered by a mountain, to the south by the ocean. It is therefore logical to regard the town as a unit when a safe environment and the town's general appearance and health are considered. Residents' lives are intertwined; all share the same public spaces. Any initiative to benefit the community should consider and include all who make this town their home.

4. Overstrand Municipality's IDP

The proposed supplementary service will be in line with and linked to OM's IDP (*Final Integrated Development Plan (IDP) review and amendment 2024-25 - 31 May 2024*). To make sure that the service complies with the directives of the IDP, this business plan has been compiled in consultation with officials of the OM. Everything possible has been done to make sure that the plan is consistent with the Overstrand Municipality's IDP as per the Service Departments' business plans.

Every stage of the plan has been and will be submitted to the office of the CFO for comments, suggestions and approval, also in coordination with municipal departments.

5. Public opinion survey

5.1 Database of rateable properties

In accordance with par 10.1.6 of the *OM Special Rating Area Policy*, OM has provided the steering committee with the contact details of property owners in Kleinmond.

The database is updated annually. The KSRA Board signed an agreement of confidentiality. Property owners' contact details were and shall only be used for communicating with ratepayers about matters concerning KSRA. It will not be made available to a third party.

5.2 Methodology

The KSRA Board has conducted a public opinion survey aimed at determining, among other things, how safe respondents feel in public spaces during the day and night, testing perceptions regarding the activities of KSRA, identifying what respondents believe KSRA should focus on, determining whether property owners believe they are getting value for their money, and assessing whether respondents are in favour of extending the KSRA term for another five years.

The internet-based platform SurveyMonkey was used to gather and process responses.

A link to the survey was e-mailed to all property owners of whom the steering committee had e-mail addresses, together with the request to complete the survey. This request was repeated three times. It was also posted multiple times on social media. SurveyMonkey recorded each respondent's IP address and these, together with the responses, are available for verification purposes. Respondents were also asked to provide their names and addresses and, where applicable, the address and name of the trust under which the property was registered. This was done for verification purposes and is not included in the publicly released report in order to maintain the anonymity of respondents. The platform was open for respondents from 28 May to 26 June 2024, after which the results were processed.

5.4 Responses analysed

SurveyMonkey analysed the responses and the unabridged analysis is provided in Appendix C and D.

- **Participation**
571 respondents participated in the survey. This represents more than 16% of the total number of individual property owners, which, in terms of generally accepted norms for the validity of surveys of this nature, is far more than sufficient.
- **Status of respondents**
87.22% of the respondents are property owners and 9.11% are authorized representatives of property owners.
- **Categories of property**
97.36% are owners of residential property, 1.05% own businesses and, 1.58% own vacant land.
- **Use of property**
71.25% use it as their primary residence, 23.67% as a holiday home, 4.24% as a rental property and 0.88% as a business.
- **Knowledge about KSRA**
70.6% of respondents say they understand the functions and responsibilities of KSRA, 21.83% say they know little about it, 4.93% say they only know that they pay for it and 2.64% say they have no idea what it is about.
- **Daytime safety when alone in public spaces**
Respondents were asked to rate their sense of safety on a scale from 1 (least safe) to 5 (completely safe):
2.28% chose 1 or 2,
8.06% chose 3 and
89.67% chose 4 or 5.
- **Evening safety when alone in public spaces**
Respondents were asked to rate their sense of safety on a scale from 1 (least safe) to 5 (completely safe):
18.21% chose 1 or 2,
25.57% chose 3 and
56.22% chose 4 or 5.
- **Late-night safety when alone in public spaces**
Respondents were asked to rate their sense of safety on a scale from 1 (least safe) to 5 (completely safe):
36.42% chose 1 or 2,
29.07% chose 3 and
34.5% chose 4 or 5.

- **Daytime safety when in a group in public spaces**
 Respondents were asked to rate their sense of safety on a scale from 1 (least safe) to 5 (completely safe):
 1.4% chose 1 or 2,
 5.08% chose 3 and
 93.52% chose 4 or 5.
- **Evening safety when in a group in public spaces**
 Respondents were asked to rate their sense of safety on a scale from 1 (least safe) to 5 (completely safe):
 6.13% chose 1 or 2,
 17.69% chose 3 and
 76.19% chose 4 or 5.
- **Late-night safety when in a group in public spaces**
 Respondents were asked to rate their sense of safety on a scale from 1 (least safe) to 5 (completely safe):
 19.26% chose 1 or 2,
 23.12% chose 3 and
 57.62% chose 4 or 5.
- **The Role of KSRA in crime prevention**
 79.12% of respondents believe that KSRA plays an important role in crime prevention in public areas,
 12.11% think its role is limited,
 1.93% believe it doesn't really make any difference and
 6.84% are unsure.
- **The importance of cooperation in crime prevention**
 94.22% of respondents agree with KSRA's position that cooperation between various stakeholders in crime prevention to increase effectiveness, is important,
 3.68% think it has a limited impact,
 0.35% see no need for cooperation and
 1.75% are unsure.
- **Focus areas**
 55.09% of respondents request that more poles with cameras be erected at strategic locations,
 34.74% believe that the current number of poles with cameras should be maintained and that investment should instead be made in improved monitoring and response and
 10.18% are unsure.
- **Reporting crime**
 95.04% of respondents say that when they are victims of crime or by-law violations, they report it to the police or municipal law enforcement and only
 4.96% do not report it, giving various reasons recorded in the full report (Appendix D).
- **Reporting environmental issues**
 80.63% of respondents believe that KSRA plays an important role in monitoring and reporting issues related to a clean and healthy environment and following up on these in monthly meetings with the councillor and municipal officials.
 10.21% think its impact is limited,

2.82% believe it doesn't really make any difference and 6.34% are unsure.

- **Perceptions of how KSRA promotes safety in public areas**

Respondents were asked to rate their satisfaction on a scale from 1 (most unsatisfactory) to 5 (highly satisfactory):

3.86% chose 1 or 2,
14.01% chose 3 and
82.14% chose 4 or 5.

- **Perceptions of how well KSRA promotes a clean and healthy environment**

The respondents were asked to rate this on a scale from 1 (most unsatisfactory) to 5 (highly satisfactory):

7.18% chose 1 or 2,
17.34% chose 3, and
75.48% chose 4 or 5.

- **Perceptions of KSRA's monthly reports via email and the media**

The respondents were asked to rate this on a scale from 1 (most unsatisfactory) to 5 (highly satisfactory):

4.03% chose 1 or 2,
5.95% chose 3, and
90.02% chose 4 or 5.

- **Opinions about the KSRA Board of Directors**

The respondents were asked to indicate their trust in the governance and management capabilities of the KSAG Board of Directors on a scale from 1 (no at all confident) to 5 (very confident).

3.17% chose 1 or 2,
9.68% chose 3, and
87.15% chose 4 or 5.

- **Value for money**

The respondents were asked to indicate their opinion on the value for money provided by KSRA's services, measured against their monthly contribution, on a scale from 1 (not at all valuable) to 5 (extremely valuable).

4.57% chose 1 or 2,
14.24% chose 3, and
81.2% chose 4 or 5.

- **Should KSRA's term be extended?**

The respondents were asked to indicate on a scale from 1 (strongly oppose) to 5 (strongly support) whether they support the extension of the KSAG term for another five-year period.

3.34% chose 1 or 2,
5.61% chose 3, and
91.05% chose 4 or 5.

6. Vision, mission and goals

6.1 Vision

The vision of KSRA is to ensure that Kleinmond remains a safe, clean and healthy town for the benefit of all its residents and visitors so that Kleinmond can remain the retirement, residential and workplace as well as holiday destination of choice for all its residents and visitors.

6.2 Mission

It is the mission of KSRA to deliver supplementary municipal services as determined by the community itself to ensure, in a sustainable manner, a safe, healthy and clean environment for residents and visitors. The service should be supplementary to those services already provided and rendered by OM.

6.3 Goals

6.3.1 Management

- To manage the proposed KSRA effectively and sustainably.

To reach this goal a non-profit company (NPC) with members was formed as defined in section 1 of the Companies Act No 71 of 2008.

6.3.2 Safe environment

- To promote and enhance a safe environment for all residents within the framework of the relevant OM legislation together with OM Protection Services and community involvement.
- To put in place a CCTV camera system linked to a control room.
- To comply with OM's strategies and other applicable legislation/policies/by-laws in relation to, among others, regulation of external and internal privately owned CCTV cameras on OM property, inclusive of open spaces, road intersections, road reserves, etc.
- To comply with OM CCTV policy.
- To obtain the service of a properly equipped local control room for 24/7 monitoring.
- To appoint a service provider accredited according to the Private Security and Investigative Services Act (PSISA) and registered at the Private Security Industry Regulatory Authority (PSIRA).
- To provide monitoring and reporting services as supplementary support for the OM Community Safety department. The service provider should be enabled to act in public places and address problems within its legal mandate until the responsible OM Law Enforcement officials or the SAPS arrive at the scene.
- To give access to data collected by the monitoring system so that any criminal acts or acts in violation with municipal by-laws can be investigated by OM Law Enforcement or the SAPS and the necessary evidence for successful prosecution can be found.
- To establish an effective communication system with regular tips and suggestions regarding a safe environment.
- To facilitate communication with property owners.

- To create and maintain a database with relevant information about residents that will be available in emergency situations. This information will be confidential and will not be shared with any third party.
- To provide input regarding the creating, testing, implementing and updating of an emergency plan for Kleinmond as supplementary to the OM Disaster Management Plan.
- To coordinate community involvement, if needed, during the execution of the emergency plan.
- To build on existing working relationships with the Community Safety Forum and other organisations involved with maintaining a safe environment through the relevant OM departments.

6.3.3 Clean and healthy environment

- To support OM by monitoring problem areas in order to report on illegal littering; rubbish dumping; blockage of storm water canals; areas and residences that constitute a fire hazard; alcohol abuse in public areas; issues regarding problem animals, the need for the clearing of alien vegetation and fire breaks and the maintenance of foot paths and board walks.

7. Implementation plan

7.1 Services

Service providers will be outsourced for the following:

7.1.1 Monitoring

- Erecting a high technological camera monitoring system within the boundaries of Kleinmond.
- Maintaining the monitoring system.
- Providing facilities and 24/7 monitoring in a well-managed control room within the boundaries of OM.
- Providing an internet service for the system.
- Supplying software for the system.
- Supplying internet connection to the LPR database within the requirements of the *Protection of Personal Information (POPI)* and the *Promotion of Access to Information* acts.

7.1.2 Monitoring and enforcement services

Providing monitoring and response staff with the necessary qualifications as well as a shared or dedicated response vehicle for Kleinmond.

Service providers will be appointed by the KSRA Board according to the tender requirements of the KSRA.

7.3 Placement of monitoring cameras

KSRA cooperates with OM Protection Services, the local police, the Street Watches and security companies to combat crime in public areas.

To achieve this KSRA has installed 17 poles with 41 cameras at strategic positions in all the suburbs. This was done after the approval of OM in terms of its CCTV Policy. The cameras are monitored by KSRA's service provider, in a dedicated control room.

The system captures information in public areas that can be used whenever footage is needed about incidents in the vicinity of a camera. At night the cameras are set up to activate automatically when there is human or vehicle movement in their field of vision. These movements are monitored and, if deemed suspicious, the response vehicle is sent out to investigate. If there is a likelihood of criminal activity, the police or OM Law Enforcement is called in to investigate further. If the recorded material can assist the police or the OM Law Enforcement in their investigation, and a case is opened, the relevant footage can be requested.

7.4 Further phases of implementation

The KSRA Board plans to erect three more poles with seven cameras at strategic positions in the next phase.

8. Financial Impact

KSRA (NPC) will be funded by OM through a special rate payable by all property owners who do not receive rates exemption. The OM has identified properties that qualify in terms of policies as the source of the additional rate. This list of properties will be regularly amended to accommodate changes in ownership as time goes by.

8.1 Source of funds

Funding of KSRA will be provided by OM and sourced from an SRA rate charged by OM and applied to the owners of valid rateable properties on the OM property database.

The additional monthly rate payment for KSRA will be determined by the property's municipal valuation and will amount to a rate (currently 0.000346) in the rand on the municipal property valuation per annum. The table below (provided by OM), gives an indication of how much property owners would be required to pay in the 2025/6 year of implementation.

8.2 Criteria to qualify for exemption

In this matter KSRA will follow the Overstrand Municipality Special Rating Area policy:

"7.1 The Overstrand Municipality's rates policy applies with the necessary changes to this Policy. In particular, and without limiting the generality of the afore-going, Section 17 of the Property Rates Act, the exemptions, rebates and reductions set out in the Rates Policy apply with the necessary changes in relation to the levying of an additional rate for special rating area purposes.

"7.2 Notwithstanding the provisions of paragraph 7.1 above, when the Municipality grants a partial rebate as set out in the Rates Policy, the relevant property owner will be granted a full (100%) rebate in relation to the additional rate.

*"7.3 Other policies approved by the Council apply with the necessary changes to the collection of additional rates in terms of the Policy, the By-Law and section 22 of the Property Rates Act, including, but not limited to, the Overstrand Municipality Credit Control and Debt Collection Policy."*⁴

Property owners who qualify for full or partial exemption from property tax do not have to pay the special KSRA rate.

8.3 Five-year term budget

According to the OM's SRA policy the budget for the proposed improvements or upgrades must at least address the following:

- *"An annual budget per line item commencing on 1 July of the first year and ending on 30 June of the last year of the term; and*
- *a budget split for the provision of improvements or upgrades between the different categories of properties.*
- *subject to the provisions of the Property Rates Act, the additional rate in any category of property must not exceed 25% of the municipal property rate. Any deviation must be fully motivated to Council for consideration."*⁵

However, while the above is the official policy, it is the aim of the KSRA Board that the additional rate should not exceed 10% of the municipal property rate.

8.4 Other requirements

“Before the Overstrand Municipality will pay over any additional rates collected to the NPC, the NPC and the Overstrand Municipality must have concluded a written finance agreement regulating, amongst other things:

- *the mechanisms and manner of payment;*
- *how the additional rate is to be held by the NPC;*
- *any parameters relating to expenditure; and*
- *any obligations on the NPC to take out and maintain appropriate insurance.”⁶*

This agreement was closed on 20 July 2021.

8.5 Existing inequities

As in every other town in the country inequities exist in Kleinmond. One of these is the inequity in financial means. It is important that inequities should not be exacerbated by establishing an SRA as required by the policy par 6.2. KSRA funding will be based on the municipal valuation of properties. This means that every rateable property owner will contribute as an additional rate the same number of cents in the rand value of his/her property, as every other property owner.

Standard municipal rebates and exemptions as currently exercised will also apply to this special rate.

9 Management Structure

The KSRA non-profit company was established on 28 January 2021 and registered with the Companies and Intellectual Property Commission.

9.1 Board of Directors

The NPC currently has 5 (five) directors, each with specific portfolio(s) aligned with the business plan of the KSRA.

The Board of Directors is appointed by the members of the KSRA NPC at Annual General Meetings and consists of the following portfolios:

- A Chairperson (currently responsible for administration and communication)
- A Vice Chairperson (currently responsible for operational functions, liaison with the service provider and networks, such as the Overstrand Joint Public Safety Forum, JOCOM and the OM Ward 9 committee)
- A second Operational Director (responsible for operational functions, infrastructure, liaison with the service provider and networking with community leaders)
- A Financial Director (oversees the work of the appointed Financial Administrator regarding the KSRA budget and financial management and liaison with the OM CFO)
- A Director for a clean and healthy environment (responsible for monitoring and reporting issues regarding a clean and healthy environment.)

The KSRA Financial Administrator serves in an advisory capacity on the Board.

The Board of Directors has monthly meetings except for December.

“The Executive Mayor will appoint councilor(s) as director(s) and alternate director(s) as representative(s) of the Municipality, who shall attend and participate in, but not vote at

meetings of the management body, to the board of the management body in accordance with sections 11(4) and 11(5) of the By-law. The director(s) appointed by the Executive Mayor will not have the powers and duties of directors as set out in the Companies Act and the management body's MOI;"⁷

9.2 Annual General Meeting

An AGM will be scheduled within two months after the end of each financial year.

The AGM will be responsible for:

- the appointment of directors;
- the review of the chairperson's Annual Report;
- the approval of the audited financial statements;
- the approval of the following year's budget and implementation plan;
- the appointment of an auditor;
- the amending of the NPC's MOI if required and with prior written consent of the CFO and
- the approval for the KSRA Board to apply for the extension of the KSRA term once every five years.

10. Website

KSRA has a website which has the following content:

- The agendas, reports, presentations and minutes of AGMs;
- the Overstrand Municipality Special Rating Area By-law;

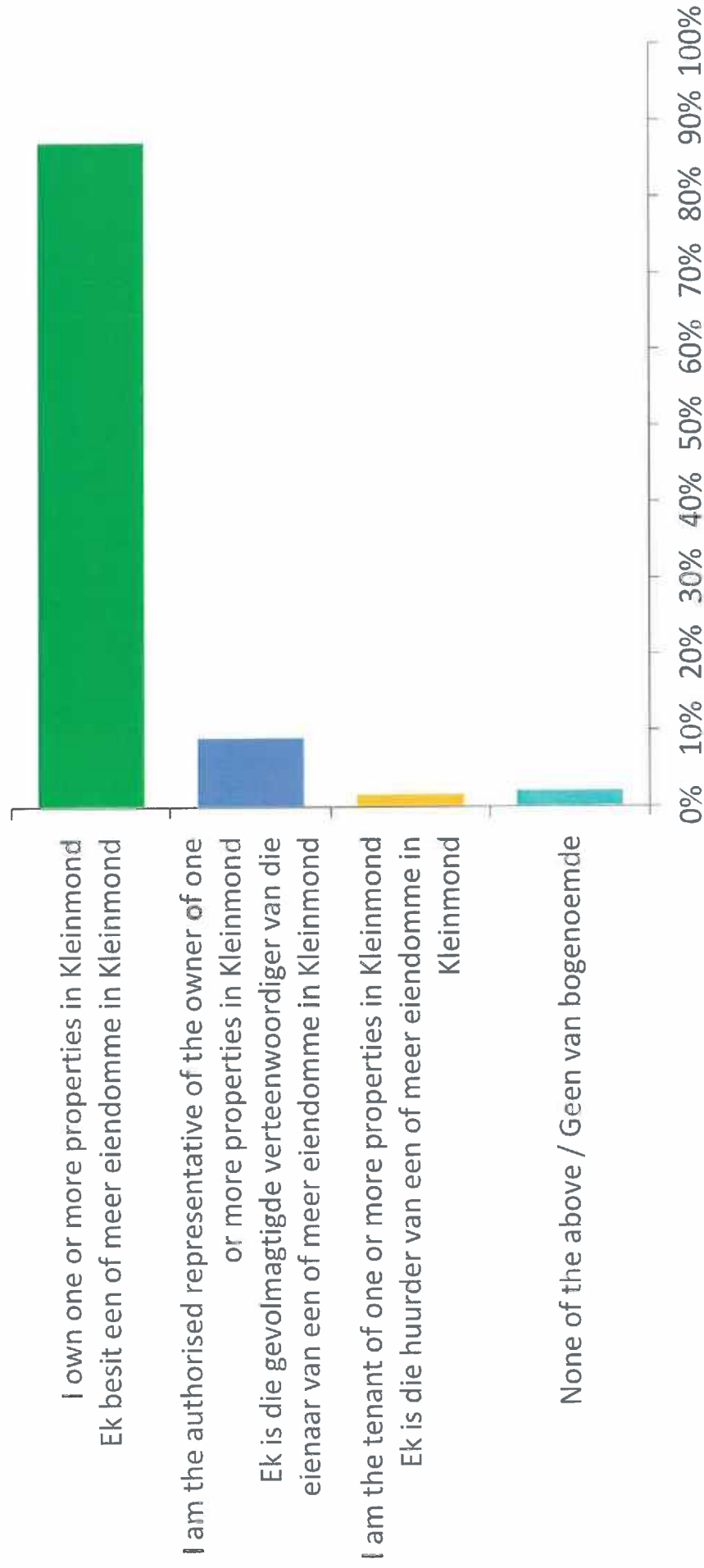

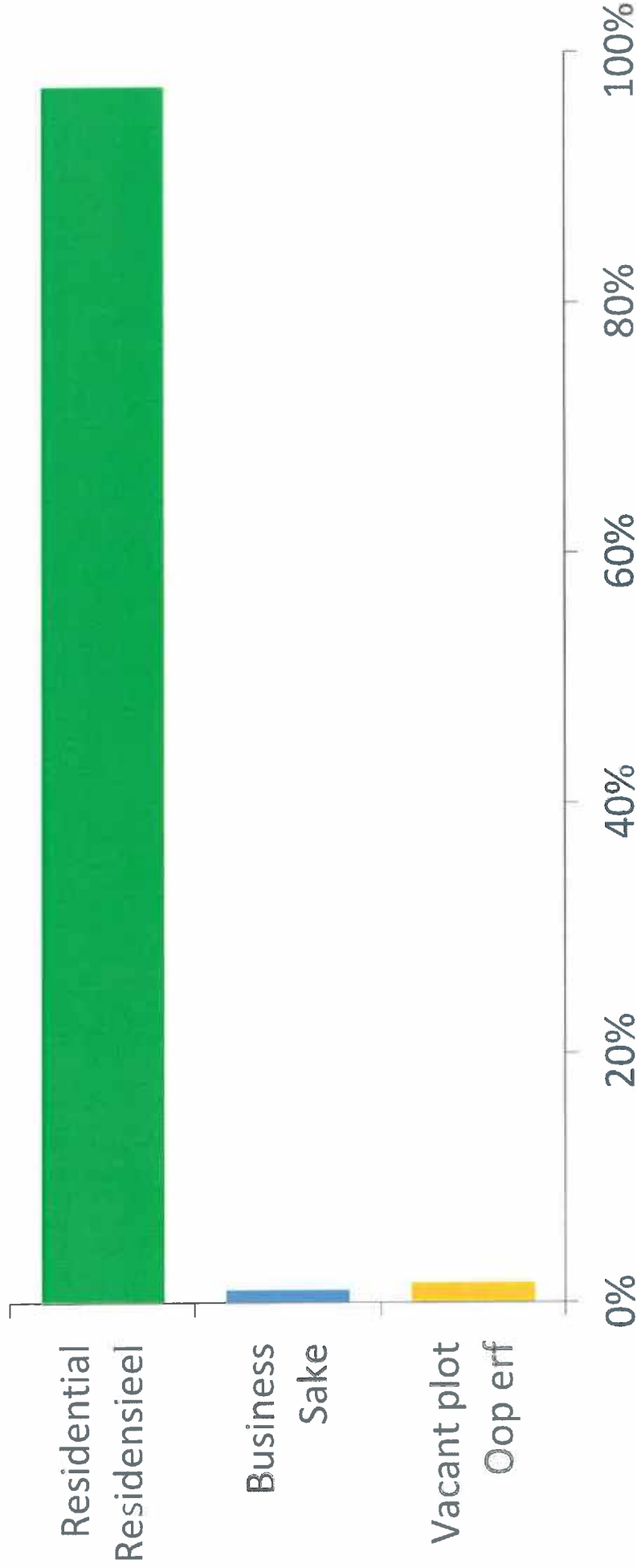

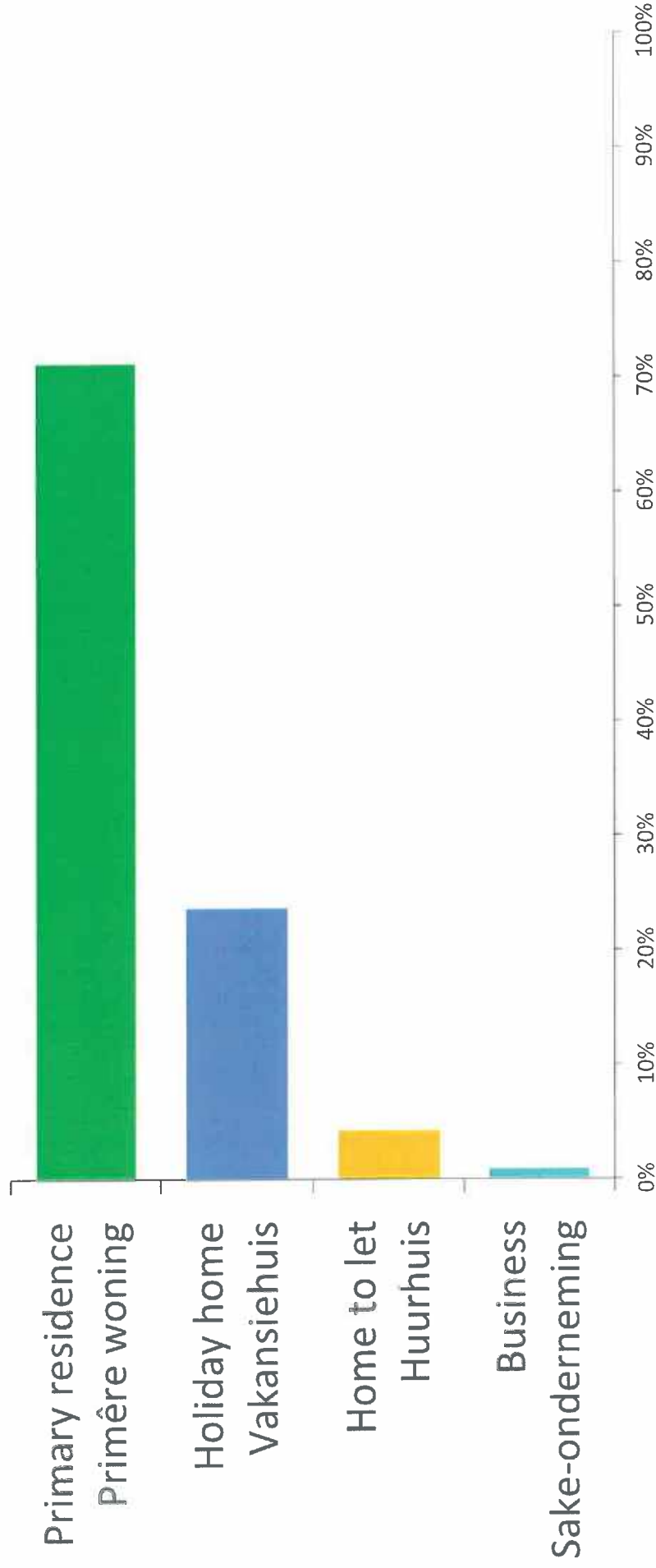

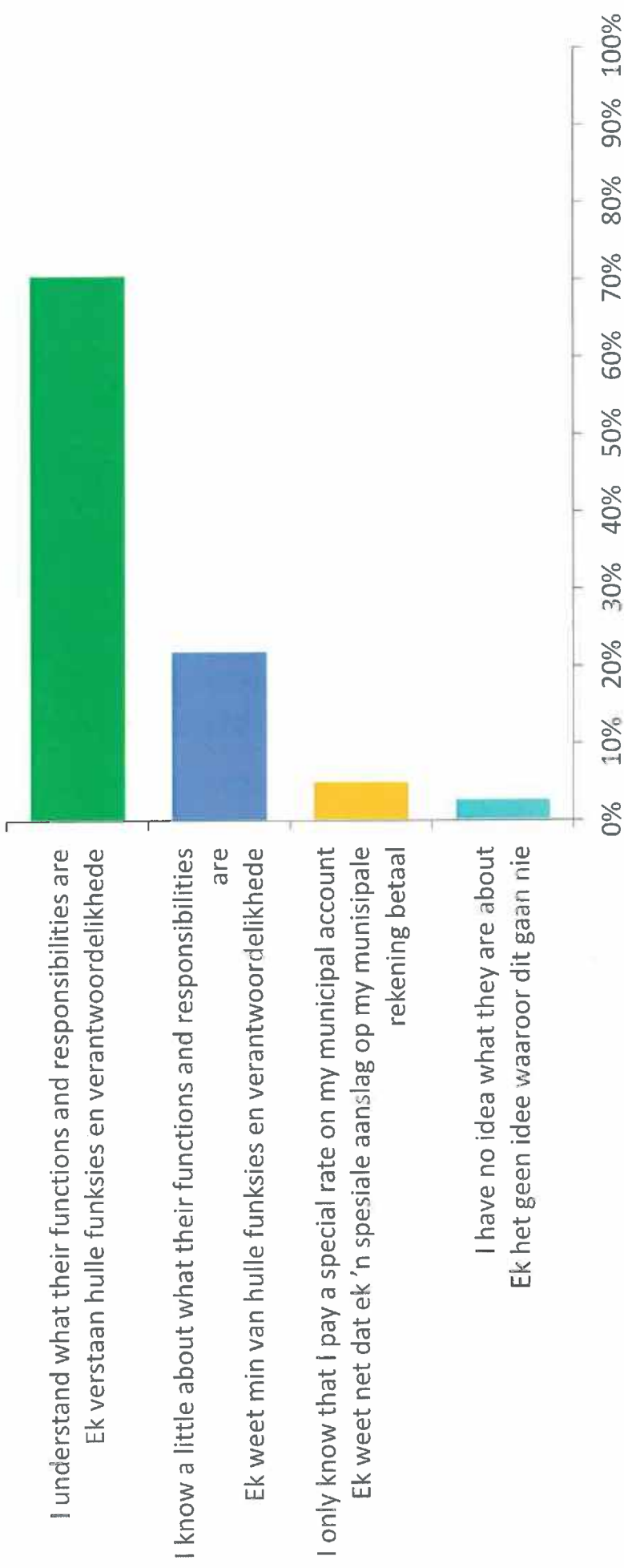

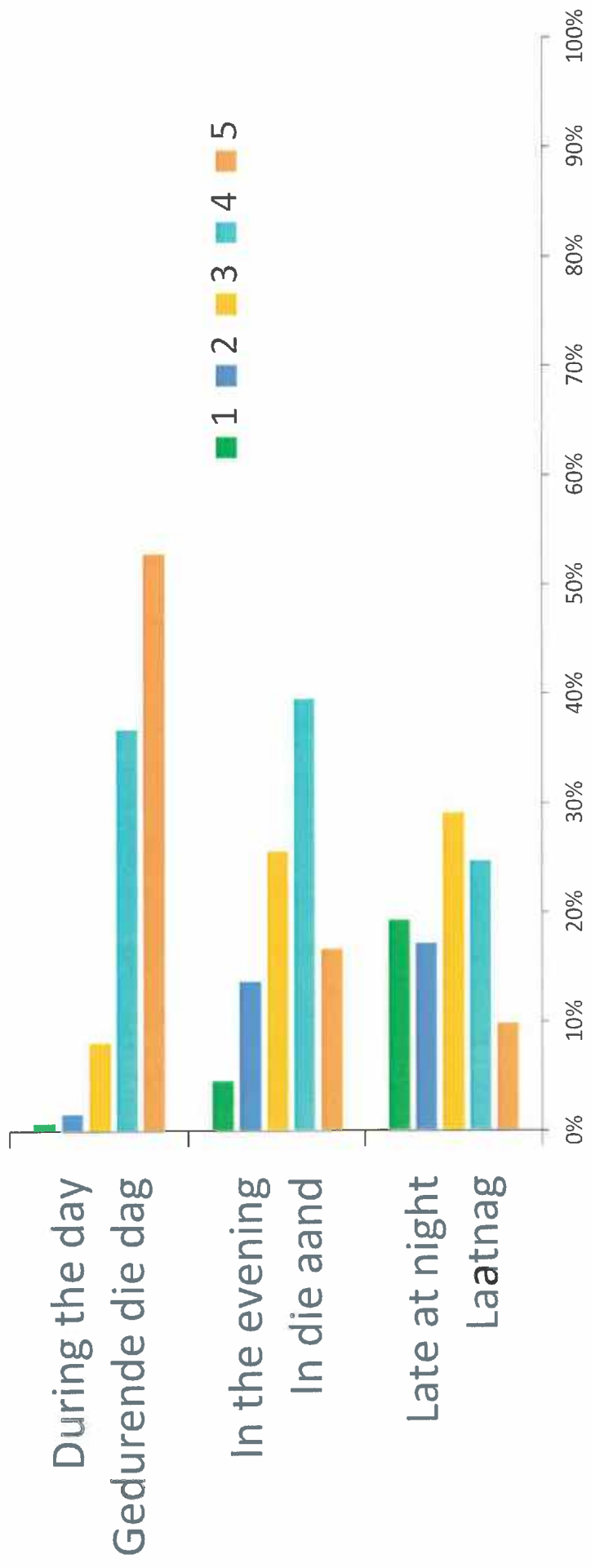

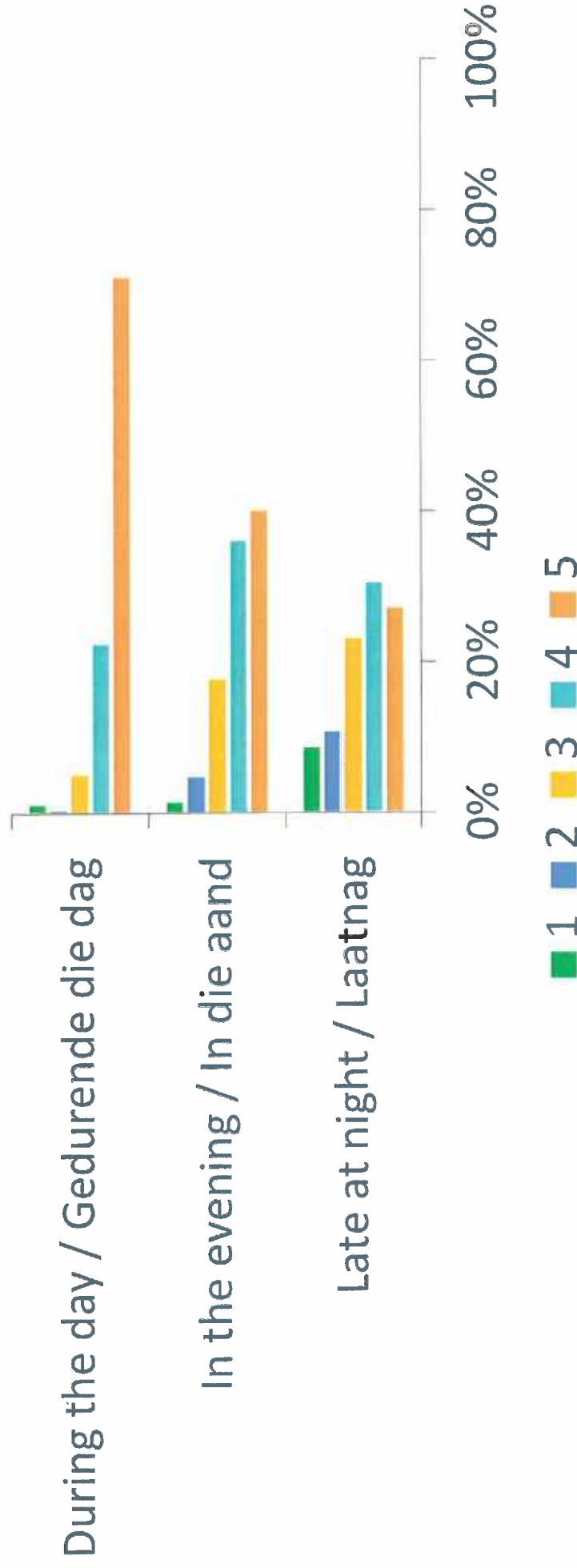

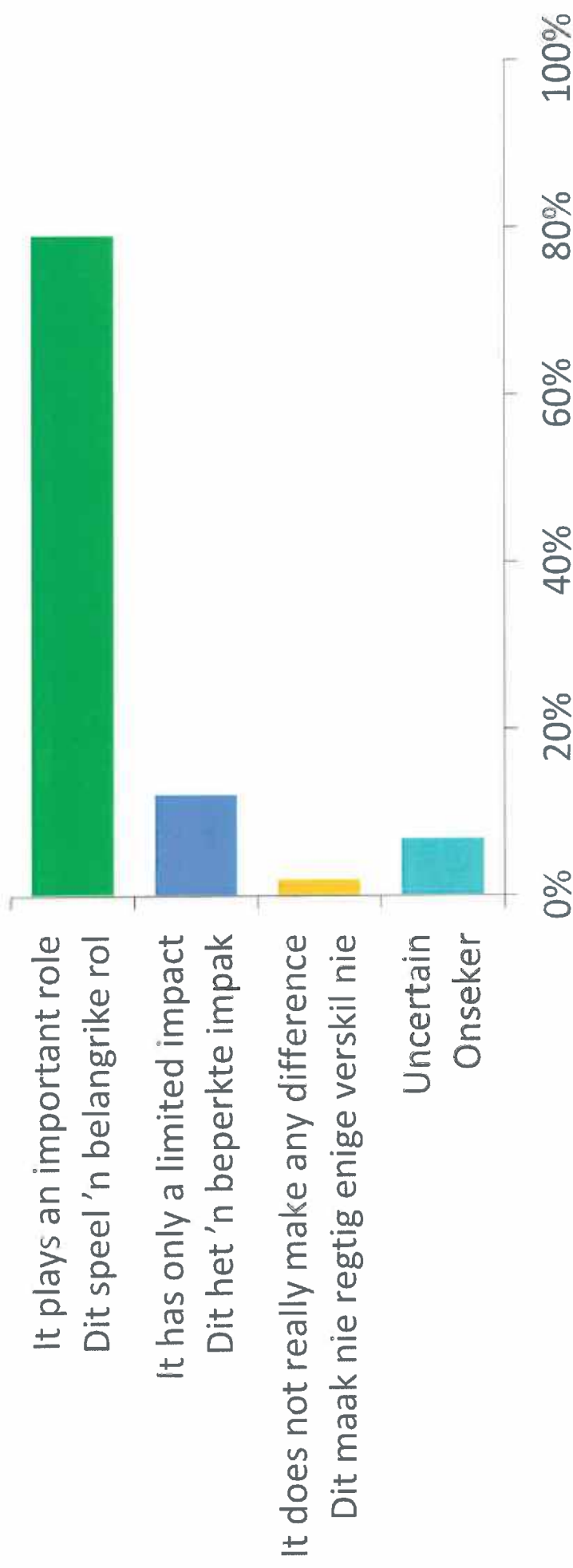
