


4. STATEMENTS AND COMMUNICATIONS BROUGHT FORWARD BY THE EXECUTIVE MAYOR / DEPUTY EXECUTIVE MAYOR

- The Executive Mayor, Ald A Rabie, informed the meeting that she attended the interim Fernkloof Advisory Board (FAB) meeting to determine what their plans are and she requested that they issue a short press release in this regard.
- The Executive Mayor, Ald A Rabie, expressed her concern about the state of certain services in the Kleinmond Administration.
- The Executive Mayor, Ald A Rabie, requested the Municipal Manager, Dr D O'Neill, to communicate with Mr Ockhuis from Eskom regarding their commitment to service their clients.
- The Executive Mayor, Ald A Rabie, informed the meeting that she will have a meeting with Cape Nature regarding returning the baboon function back to them as well as to find out what happened to the funds earmarked for this function. She will also address the manner in which DAFF is treating coastal anglers and how they deal with poachers.
- The Executive Mayor, Ald A Rabie, queried about the current status of the RDP Centre in Zwelihle as well as the Zwelihle Mall and requested that a meeting be held with the RDP Board.
- The Municipal Manager, Dr D O'Neill, reported on the status of the traffic light at Brug Street, Main Road Intersection, Eastcliff informing the meeting that Province plans to allocate additional funding for provincial roads in the municipal area in the next financial year. This may create an

opportunity to fund some of the expenses for the changes to the Brug Street intersection.

- The Executive Mayor, Ald A Rabie, expressed her concern that not enough MPAC meetings are held, and the CFO reported that MPAC meetings are scheduled for 22 May 2024 and 11 June 2024.
- The Executive Mayor, Ald A Rabie, expressed her concern about the high water usage in Paradise Park and requested the Municipal Manager to investigate the matter further.
- The Municipal Manager, Dr D O'Neill, reported on the progress of the Placement Committee.
