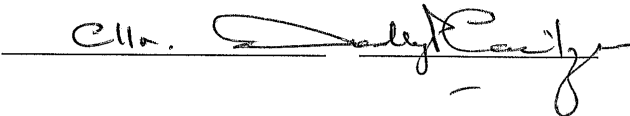
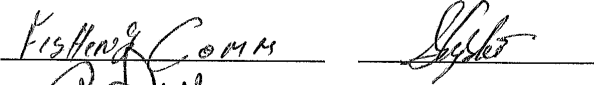
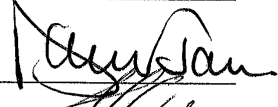

Die voorsitter rapporteer dat 'n vergadering tussen die munisipale bestuurder, uitvoerende burgemeester en ander rolspelers geskeduleer is vir 22 Mei 2012. Die hersiene beleid sal gesirkuleer word vir kommentaar.

The chairperson reported that a meeting was scheduled for 22 May 2012 between the municipal manager, executive mayor and other roleplayers. The reviewed policy will be circulated for comments.

4.3 Spoeidkontrolle in Stanford / Speed Control in Stanford

Mnr B Jones rapporteer dat voorstelle in hierdie verband van Mnr J Williams ontvang is, en dat die Stanford Belastingbetalersvereniging dit met simpatie bestudeer het. Dit behels dat motoriste opgevoed word om spoed te verminder wanneer hulle 'n dorpsarea nader. Motoriste stop nie by stopstrate in Stanford nie. Me Ward versoek dat die 4-rigting stop op die hoek van Queen Victoria- en Moorestraat ondersoek word, asook die verkeersprobleme wat soggens ontstaan by die taxi-staanplek. Mnr L Isaacs word aan die woord gestel en versoek dat 'n klage aanhangig gemaak word in hierdie verband by Me P Ferreira, sodat dit ondersoek kan word. Hy berig verder dat spoed-toepassing altyd deel van die opvoedingsproses van motoriste sal uitmaak. Die voorsitter versoek dat, aangesien Mei/Junie 2012 kinderbeskermingsmaand is, Mnr Myburgh namens wyk 11 'n skrywe aan die verkeersdepartement rig. Me Ward versoek dat 'n wit lyn in Dreyerstraat gevestig word en kinders opgevoed word om slegs van die voetganger-oorgang gebruik te maak.

Mr B Jones reported that certain proposals were received from Mr J Williams with regard to speed control in Stanford and that the Stanford Ratepayers' Association looked at these proposals with sympathy. He requested inter alia that motorists be educated to slow down when approaching a village. Motorists are also not stopping at stop streets in Stanford. Ms Ward requested that the 4-way stop on the corner of Queen Victoria and Moore Street be investigated, as well as the traffic problems which occur in the mornings at the taxi rank. Mr L Isaacs was introduced to the meeting and he requested that a complaint be submitted to Ms Ferreira so that the problem can be investigated. He reported further that speed control will always be part of ongoing training amongst motorists. The chairperson requested that, because May/June 2012 is child protection month, Mr Myburgh addressed a letter to the traffic department in this regard. Ms Ward requested that a white line be established in Dreyer Street and children be educated to only make use of the pedestrian crossing.

5.1 **Working for the Coast (Khoisan Implementing Agent) : Progress Report**

Die operasionele werksaamhede van die organisasie is sedert die laaste vergadering afgeskaal, aangesien werkers opleiding ontvang het. 'n Dokument wat handel oor riete-beheer is ontvang van Me B Whittaker en word ook ter tafel gelê. Die voorsitter versoek dat Mnr Frith 'n vergadering belê met Me Whittaker, die Stanford Bewaringsvereniging en Liaan Geldenhuys, asook Mnr Pierre de Villiers, Kaapse Natuurbewaring se verteenwoordiger vir opvanggebiede om vas te stel of 'n studie in hierdie verband geloods kan word.

The minutes of the meeting which was chaired by Ms Ferreira with Khoisan, was tabled. The operational activities of Khoisan was scaled down since the last meeting, as workers received training. A document addressing the removal of reeds which was received from Ms Whittaker, was also tabled. The chairperson requested that Mr Frith set up a meeting with Ms Whittaker, the Stanford Conservation Trust, as well as Liaan Geldenhuys, together with Mr Pierre de Villiers, Cape Nature's estuaries manager, to determine if a study can be done in this regard.

Soccer field: budget is almost 100% spent. The surface was levelled and top soil was ordered.

Alien Vegetation: On schedule.

Rapair pavements, Queen Victoria Street: Completed.

Water Quality Monitoring: Reallocated.

Public Toilets, Cemeteries: Reallocated.

Upgrading Stanford Community Hall: The remainder of the funds is now with supply chain management and the project will be handled as a LLP project.

Maintenance of Stanford Sports Fields: Total amount has been budgeted for. Iron gates were ordered.

Bush-clearing, Eluxolweni: Project is completed.

Hot-house (vegetables): Service provider was appointed.

B'Bos Community Hall Equipment: Completed.

Upgrade of Tourist Facilities: Completed.

New Street Names: Completed.

Concrete Benches and Tables: Completed.

Storm Water Drainage Master Plan, Stanford: Consultants will submit their report to the administration on 18 May 2012, and the report will be submitted at the next meeting.

5.4 Gebruik van Bootlanseerplekke / Using of Boat-launching Sites

Mnr Liaan Geldenhuys verduidelik aan die vergadering dat die Departement van Omgewingsake 'n tyd gelede 21 bootlanseerplekke langs die kus geïdentifiseer het wat geregistreer moet word, waarvan 9 in die Overstrand. Stanford se bootlanseerplek is een van dié wat geïdentifiseer is. Mnr Myburgh berig dat dit nie die verantwoordelikheid van die munisipaliteit is om bootlanseerplekke te registreer nie. Mnr Geldenhuys sal die wykskomitee op hoogte hou. 'n Aansoek vir die registrasie van Buffeljacht se bootlanseerplek is ontvang.

Mnr Liaan Geldenhuys reported that the Department of Environmental Affairs identified 21 slipways along the coast which must be registered, of which 9 are in the Overstrand. Stanford slipway is one of those to be registered, but Mr Myburgh reported that it is not the responsibility of the municipality to register slipways. Mr Geldenhuys will keep the ward committee informed. An application was received for the registration of the Buffeljacht boat-launching site.
