



#### WATER RESTRICTIONS: GREATER HERMANUS AND KLEINMOND AREAS

Notice is hereby given in terms of the Overstrand Water Services Bylaw, Clause 47, that water restrictions will be implemented in the Greater Hermanus (i.e. Benguela Cove to Voëlkloof) and Kleinmond areas as from 26 September 2023 until further notice.



#### THE FOLLOWING MEASURES WILL APPLY TO ALL CONSUMERS:

- No watering of gardens, flower beds, sports fields, parks, lawns and other open spaces is allowed with municipal drinking water
- No filling of swimming pools with municipal drinking water is allowed
- No washing of vehicles and watercraft with municipal water is allowed

The municipality will provide water tankers in the various suburbs in the event that the reservoirs run dry.

Please stock up on bottled water and assist us in ensuring that the little water we have can last as long as possible until the water lines have been restored.

- If alternative water sources are utilized, consumers must ensure that they display the appropriate signage to this effect, clearly visible from a public thoroughfare.

#### WATERBEPERKINGS: GROTER HERMANUS EN KLEINMOND GEBIEDE

Kennis geskied hiermee in terme van die Overstrand Waterdienste Verordening, klosule 47, dat waterbeperkings met ingang van 26 September 2023 tot verdere kennismetting ingestel word in die Groter Hermanus (d.w.s. Benguela Cove tot Voëlkloof) en Kleinmond gebiede.



#### DIE VOLGENDE MAATREËLS SAL VAN KRAG WEES OP ALLE VERBRUIKERS:

- Geen natlei van tuine, beddings, sportvelde, parke, grasperke en ander oop ruimtes met munisipale drinkwater word toegelaat nie
- Geen vul van swembaddens met munisipale drinkwater word toegelaat nie
- Geen was van voertuie en watervaartuie met munisipale water word toegelaat nie

Die munisipaliteit sal water tenkwaens in die verskillende voorstede voorseen in die geval dat die reservoirs soos tans opdroog slegs water vanaf die Gateway Wellfields tans voorseen kan word.

Maak asseblief gebruik van op gebottelde water en ons help om te verseker dat die bietjie water ons het kan so lank as moontlik hou totdat die waterlyne herstel is.

- Indien alternatiewe waterbronne gebruik word, moet verbruikers verseker dat 'n toepaslike kennismetting duidelik sigbaar is vanaf 'n publieke deurgang.

- Akuvumelekanga ukuhlanjwa kwezithuthi kunye neenqwelo zamanzi ngamanzi kamasipala
