

INVITATION FOR COMMENTS WITH REGARD TO ADDITIONAL REVISIONS OF THE OVERSTRAND MUNICIPALITY BY-LAW ON MUNICIPAL LAND USE PLANNING, 2015, THE OVERSTRAND MUNICIPALITY ZONING SCHEME, 2013, THE RESPECTIVE OVERLAY ZONES AND THE INTEGRATION OF THE ZONING MAPS INTO THE REVISED OVERSTRAND MUNICIPALITY LAND USE SCHEME (REGULATION), 2013

Notice is hereby given in terms of Section 17 of the Municipal Systems Act, 2000 of the intended additional revisions of the Overstrand Municipality By-law on Municipal Land Use Planning, 2015.

Notice is further given in terms of Section 24 of the Spatial Land Use Management Act, 2013 and Section 22 of the Western Cape Land Use Planning Act, 2014 and Section 13 of the Overstrand Municipality By-law on Municipal Land Use Planning, 2015 for the following:

- additional amendments to the Overstrand Municipality Zoning Scheme Regulations, 2013, which will constitute the Overstrand Municipality Land Use Scheme, 2013;
- additional amendments to the Environmental Overlay Zone (OZE1), Heritage Overlay Zone (OZH2) and the Stanford Heritage Overlay Zone (OZS3), which will be integrated with the revision of the Overstrand Municipality Land Use Scheme, 2013;
- the determination of zoning of a portion of Erven 4771, 4833, 4831, 249, 243 and 1253 Hermanus as Open Space Zone 1: Nature Reserve as promulgated in 2000, and
- the integration of the zoning maps into the revised Overstrand Municipality Land Use Scheme (Regulation), 2013 and the Overstrand Municipality By-law on Municipal Land Use Planning, 2015.
