### **NEW WARD COMMITTEES** **INVITATION TO INTEREST GROUPS IN THE OVERSTRAND MUNICIPAL AREA**

Interest groups in the Overstrand Municipal Area are hereby invited to register on the municipal database in preparation for election and the establishment of ward committees for the **2016 to 2020** term of office for the new Municipal Council. In order to register, the organisation/sector must be in existence for at least one (1) year.

Ward Committees act as a formal part of the governance structures and assist the Municipal Council in conducting public participation on the Integrated Development Plan (IDP), Municipal By-Laws, Budget, Policy Formulation, the Performance Management System of the Municipal Council, etc.

The representatives from the various interest groups namely; organisations/sectors and geographic/block area form the basis of each ward committee, with the Ward Councillor as the chairperson.

#### **Categories of interest groups include:**

- Organisations representing a specific interest of the community residing in the particular ward, for example youth, women, religious grouping, ratepayers associations, etc.
- Sectors representing a broader scope of similar interests (umbrella body/structure) of the community for example, Sport and Recreation, Health and Welfare, Education, Community Safety, Business, etc.
- Geographical Block/Area representing the interests of an identified geographical area (e.g. neighbourhood, extension, village) in a particular ward.
