RESORT RULES

ONRUS CARAVAN PARK

RIGHT OF ADMISSION IS RESERVED

Small breed animals of tenants will be allowed in the Resort, provided that the prior written approval of the Resort Manager is obtained. Day visitors may not bring any animals into the Resort.

- A maximum of 6 people per stand are allowed to stay overnight.
- Only 2 motor vehicles/motorcycles, or one motor vehicle with a boat and trailer, will be allowed per allocated stand, subject thereto that there is sufficient space for same, and must be parked on the stand. No parking shall be allowed on any communal area in the Resort. An additional fee is payable for the second vehicle.
- Quad bikes and go-carts are not allowed in the Resort.
- No day visitor vehicles will be allowed into the Resort during the peak season.
- Children under the age of 7 years must be accompanied by an adult when they use the ablution facilities.
- No bicycles are allowed to be ridden in the Resort after dark for safety of riders and pedestrians.
- Be careful of moving vehicles at all times.
- Any defect and/or irregularities must immediately be brought to the attention of office staff.
- Clothing and/or dishes may not be washed in the hand basins. Fish may not be cleaned in the sinks/hand basins.
- Toilet paper is available at the office and after hours at the security if needed for the communal ablution facilities only.
- Day visitors must complete and sign an application form and hand in at the office or at the security.
- Day visitor hours: 08:00 to 22:00.
- Stands and ablution facilities must be kept neat and tidy and litter free.
- Please use bins that are provided.
- MILKWOOD TREES may not be pruned or damaged. This is a criminal offence and offenders will be liable to prosecution of R10 000 and/or 10 years imprisonment.
- Anyone that damages the Resort's property, trees or vegetation will be held liable for the cost of replacement. Should any overhanging branches be a problem on the plot, it must be reported to the office and not broken off by tenants.
- The picking of any of the flowers / fynbos or pruning of branches of any trees inside the Resort is prohibited without the prior written consent of the Resort Manager.
- Facilities are used at own risk. The Municipality accepts no responsibility for any damage, loss or injury that originated in or was sustained in the Resort.
- Electrical: Please contact the office if assistance is required.
- You are welcome to complete the complaints/suggestion evaluation form obtainable from the office and send it directly to the office of the Senior Manager: Hermanus Administration.
- The Overstrand Municipality reserves the right to change RULES, without notice.
- PLEASE NOTE: If the Resort rules and/or code of conduct are not adhered to, campers will have to leave the Resort and will forfeit all camping fees.
- Report any suspicious behaviour in order that the resort can maintain a high standard and that it remains secure and safe for all campers.
- We sincerely hope that the above ensures that you have a wonderful and relaxed stay at the Resort.

CODE OF CONDUCT

The code of conduct is strictly enforced to ensure that all the tenants enjoy their stay.

- Alcohol abuse is strictly prohibited. No person is allowed to walk around in the Resort with alcoholic drinks in bottles, cups or glasses.
- No unruly behaviour or foul language will be tolerated.
- Soft music is allowed, but NO music and/or instruments from 22H00 to 08:00.
- No loud noises allowed from 22:00 to 08:00. No exceptions will be made, and it will be enforced strictly.
- Respect the other people in the Resort.
- No smoking allowed inside the ablution facilities.
