He elaborated and gave background on the past solution of using HTH which was successful, but now due to the product becoming too expensive for the Municipality to purchase and not being used at all it is causing the problem of being slippery at the slipway which is becoming a hazardous environment to the members of the public. He requested a solution of what can be done or what can be used to remove the Algae which causes the problem.</p> |  |
